## President's Message



I write this message with renewed hope of Spring's imminent arrival and a faintly visible path for us to emerge from the COVID-19 pandemic. After having to cancel our conference in Niagara 2020 and successfully delivering a virtual conference in 2021, the

Canadian respiratory community will be meeting again in-person in beautiful Victoria for the Canadian Respiratory Conference in April 2022. Although I have appreciated the opportunity to maintain regular contact with colleagues from across the country through various virtual platforms, nothing can truly replace real face-to-face interactions.

I want to express my admiration and gratitude for the dedication, professionalism, and extraordinary efforts of our respiratory community in meeting the challenges of the pandemic. You have provided exemplary care for your patients, found innovative means to educate the next generation of health care professionals, and researched creative solutions to the problems posed by the current global respiratory health threat. Thank you!

The Canadian Thoracic Society remains very active in providing support to our members to meet the challenges of the pandemic. The CTS COVID Task Force, chaired by past president Dina Brooks, provides strategic guidance on where to prioritize our efforts. The Clinical Assemblies continue to produce high quality clinical guidance documents to help clinicians optimize management for their patients during the pandemic. The CTS has shown national leadership by regularly convening the COVID-19 Respiratory Roundtable, bringing together more than 20 Canadian respiratory professional societies and patient advocacy groups to share ideas and identify opportunities to collaborate. In the past year, we joined other professional bodies in calling for mandatory COVID-19 vaccination policies for health care workers. Under the leadership of Sanja Stanojevic, and in collaboration with the Canadian Society for Respiratory Therapists, we have advocated for protection of our members and patients against COVID-19 by hosting multiple roundtable meetings with key stakeholders and publishing best practice guidance documents to address the issue of aerosol precautions and PPE in high-risk clinical environments, such as in pulmonary function laboratories.

In terms of societal issues beyond those directly related to the pandemic, the CTS, led by Najib Ayas and the Sleep Assembly, and in collaboration with the Canadian Sleep Society, has

advocated for a resolution to the urgent situation resulting from the Philips Respironics positive airway pressure device recall. The CTS Executive and Board have also taken a firm public stance condemning the takeover of the inhaled medicines company Vectura by tobacco giant Philip Morris International. Last summer, we delivered an official written submission of recommendations to the federal government for their consideration in the development of the federal budget. The CTS will continue to work with our public relations firm Impact Public Affairs to address issues of concern to the Canadian respiratory community, such the impact of climate change on air quality and equitable access to healthcare by disadvantaged groups, where our collective voice and input can make a difference.

In line with our 2020-2023 strategic plan, launched by then president John Granton, there have been a number of important internal changes at the CTS in the past year. In order to promote the further growth and sustainability of our society we have established an investment fund and, under the leadership Jean Bourbeau, a new Business Development Advisory Committee. The CTS has recently hired a methodologist to support the exceptional work of the Clinical Assemblies and the CTS' Canadian Respiratory Guidelines Committee, chaired by Samir Gupta, to continue producing high quality, evidence-based clinical practice guidelines. Donna Goodridge has spearheaded the creation of a Palliative Care working group, which aims to improve the care and quality of life of people living with advanced respiratory disease. Most recently, we formed an Equity, Diversity and Inclusion working group, co-chaired by Sunita Mathur and Andrea Gershon, to help develop and update our leadership, management and governance policies and procedures to be fair, and to reflect, expand, and engage the diversity of our membership. Given the commitment of our members to improve the lung health of Canadians, I foresee more progress and positive changes at the CTS in the years ahead.

Lastly, I want to personally acknowledge the invaluable guidance and support provided to me over the last year by my good friends and colleagues - Past President, Dina Brooks, and other members of the CTS Executive (Richard Leigh, Mohit Bhutani, and Donna Goodridge), CTS Board members, CTS members, and especially Executive Director, Janet Sutherland (I will definitely miss our weekly Zoom calls), and the CTS staff. It has a been a privilege to serve as CTS President.

## Continuing Professional Development

#### Accreditation

- With the leadership of the CTS Education and CPD Committee, CTS was successful in renewing its status as a Royal College Accredited CPD Provider for a period of 8 years.
- In addition to its programs, CTS accredited five external programs from Alberta Respiratory Centre, Canadian Women in Medicine and Manitoba Thoracic Society.

#### **Accredited Continuing Medical Education**

- An accredited webinar was delivered on October 8th in collaboration with the Quebec Respiratory Health Research Network (QRHN) on Asthma Research and to provide an update on the CTS asthma guidelines.
- An accredited webinar for primary care physicians on the 2021 CTS Guideline on Very Mild and Mild Asthma developed for delivery in April 2022, supported by a grant from GSK.

#### CTS Scientific Program at CHEST


- The 2021 CTS Scientific Program at CHEST was held virtually as part of the CHEST Annual Meeting on Monday, October 18, 2021. The CTS program was comprised of live and on-demand sessions and featured early career faculty.
- Dr. James Martin delivered the CTS Honorary Lecture on "Irritant Asthma and Innate Immunity; a Neglected Area".

#### CTS Speakers' Bureau

- Three webinars on the 2021 CTS Guideline on Very Mild and Mild Asthma were delivered to primary care physicians for GSK in June and September 2021.
- Four other Speakers Bureau engagements on the 2021 CTS Guideline on Very Mild and Mild Asthma delivered for AstraZeneca and Covis Pharma between January-March 2021.

### 13th Annual Canadian Respiratory Conference

- Delivered our first virtual national conference April 8-10, 2021
- 511 delegates attended the virtual CRC which exceeded the expectations due to the 3D virtual conference experience and the quality of the sessions.
- Within the scientific program at CRC, the following three sessions were developed as Accredited Self-Assessment activity (Section 3)
  - Cardiopulmonary Exercise Testing Workshop
  - Pediatric Clinical Cases
  - Update in Lung Cancer: From Screening to Treatment
- Co-developed eight symposia with AstraZeneca, Boehringer-Ingelheim, Grifols, GSK (2), Janssen, Merck and Sanofi Genzyme.



# Developing the Next Generation of Clinicians and Researchers

The new model for CTS Clinical Assembly Steering Committees includes positions for Early Career representatives. Implementation of this model has been achieved with the Asthma, COPD and ILD Assemblies. The model will be implemented next in the Home Mechanical Ventilation, Sleep Disordered Breathing, and Pulmonary Vascular Disease Assemblies.

## Career development is also supported through:

- Featuring early career faculty at the CTS Scientific Program at CHEST
- Profiling young investigators as featured speakers at the Canadian Respiratory Conference
- Delivering an annual Pediatric Fellows Day and National Senior Respiratory Fellows Symposium to support preparation for the Royal College exam and transition to practice – only the practice written exam was administered to the fellows locally by Adult Program Directors in 2021
- Advertising career opportunities on the CTS website and through our 'Jobs in Respirology' ebulletin
- Hosting the Pediatric Respirology 'Cross Canada Rounds' and website.

## Directory of Fellowships and Training Opportunities

The Directory of Extended Canadian Training and Respiratory Fellowships is available in the CTS member portal. This Directory is developed by CTS in collaboration with Adult and Pediatric Respirology Program Directors across Canada.

### **Business Development**

In 2021, the CTS created a Business Development Advisory Committee (BDAC) and hired a part-time business development specialist in support of its work. The BDAC has a focus on business strategy, fund development, marketing, and promotion of CTS' portfolio of business. More specifically, over the next few years the BDAC will:

- Develop revenue generation and business development strategies
- Review and assess tactical plans and business development goals
- Diversify the corporate sponsorship model and increase opportunities to monetize and market CTS products
- Explore other business models and new partnerships to develop opportunities
- Explore the feasibility of a foundation

### **Equity, Diversity and Inclusion**

A new working group, reporting to the CTS Executive and Board, has been created to focus on equity, diversity and inclusion and to contribute to the development of an operational framework for our professional society to ensure transparency, opportunity and participation. The EDI working group will shape the development of policies and procedures in the domains of member engagement, committee participation, organizational development and governance.

# Expanding Collaboration, Expertise and Impact

- CTS continued to convene the national COVID-19
   Respiratory Roundtable, meeting 11 times in 2021 to share information, identify common issues and align education and advocacy initiatives. CTS established this pan-Canadian Roundtable of over 20 patient and professional organizations working in lung health in April 2020. This network has allowed health care professionals and patients to access the most up to date evidence-based information and medical expertise on issues impacting their lung health during the pandemic. The Roundtable is working to address ongoing issues related to post-COVID patient care.
- Aerosol Precautions and PPE Stakeholder Roundtables organized by CTS and Canadian Society of Respiratory Therapists on May 17th and November 1st to develop strategies to influence decision-makers on access and safety issues for patients and healthcare professionals
- Biologic Therapy and COVID-19 vaccine CTS developed an FAQ for clinicians and individuals with asthma as a joint initiative with the Canadian Society for Allergy and Clinical Immunology
- Development of a joint statement/media release with AMMI Canada promoting dual vaccination against influenza and COVID-19

#### Advocacy and Government Relations

In January 2021, Respiratory Roundtable stakeholders issued a <u>joint statement</u> urging the federal, provincial and territorial governments to prioritize people living with lung disease who are at higher risk for more serious COVID-19 complications in the vaccination rollout.

CTS Pre-budget Submission - A meeting was held with the Chair of the House of Commons Finance Committee to discuss CTS recommendations on federal government budget priorities, including:

- Combatting vaccine hesitancy
- Supporting the development of vaccines and treatments
- Improving outcomes for those with respiratory diseases
- Improved access to national PPE supply

Canadians with lung disease deserve early protection from COVID-19 and should be prioritized in vaccination programs.




