Position description

The Department of Medicine at McGill University invites applications for a full-time position at the rank of Associate or Full Professor (Clinical) as a member of the Contract Academic Staff. The professorial rank will be determined according to the candidate's qualifications and experience. The incumbent will be the McGill Director of the Division of Respiratory Medicine. The Department seeks a transformational leader who will take one of our highest performing Divisions to the next level of academic excellence. Applicants are encouraged to simultaneously apply for and be considered for the MUHC Director of the Respiratory Division, although this is not required, [MUHC Directorship position](#).

The Division of Respiratory Medicine is an academically productive division with a long-standing tradition of excellence. It includes over 50 faculty members, including 16 Clinician Scientists and 8 PhD Scientists. The ideal candidate will have a clear vision of the evolving nature of Respiratory Medicine, a demonstrated ability to communicate that vision, the skill to encourage others to share it and be an accomplished leader in academic medicine. Prospective candidates will have a proven academic track-record in basic and/or clinical research.

The Department of Medicine is a leader in academic medicine, and our educational and research missions support excellent and innovative clinical programs across our teaching hospitals. The McGill University Health Centre, the Jewish General Hospital and St- Mary's Hospital are major teaching hospitals affiliated with the Faculty of Medicine and Health Sciences. The ideal candidate will be a unifying force, strengthening cross-site collaboration.

The successful candidate, as McGill Director of the Division of Respiratory Medicine will have a demonstrated record of success in academic performance and leadership and draw on strong interpersonal skills to inspire best practices and innovation. They will foster excellence in teaching, patient care, and research within the Division and will demonstrate a commitment to equity, diversity, and inclusion in these activities. The incumbent will also promote independent and collaborative research, and fulfill administrative responsibilities at the institutional, university, regional and provincial levels.

The incumbent will be expected to maintain a clinical practice at the McGill University Health Centre and/or the Jewish General Hospital and/or St-Mary's Hospital.

The McGill Division Director will ensure the pursuit of a common academic agenda for McGill Respiratory Medicine at all its sites, with a focus on the following aspects:

- 1) Education, specifically undergraduate and postgraduate initiatives in Respiratory Medicine;
- 2) Research, including promoting, supporting, and incentivizing McGill-wide Respiratory Medicine research initiatives;
- 3) Clinical innovation;
- 4) Faculty development, mentorship, and wellness; and
- 5) Cross-cutting advancement initiatives.

McGill faculty members are expected to contribute to service activities within their units, the University, and the wider scholarly community. A demonstrated commitment to equity, diversity, and inclusion is also expected.

Qualifications and Education Requirements

Candidates must:

- hold an MD degree and must have completed subspecialty training in Respiratory Medicine;
- be certified by the Royal College of Physicians and Surgeons of Canada (or equivalent) and be eligible for licensure in Quebec and certification by the Collège des médecins du Québec;
- have strong leadership experience; demonstrate internationally-recognized academic accomplishment in Respiratory Medicine research and teaching;
- have clinical expertise suited to tertiary hospital settings;
- have experience in training students, residents, and fellows in clinical settings;
- be fluent in English with a working knowledge of French. Candidates must be able to interact in English and in French with patients, families and health care professionals.
